2 Castle Hill Lostwithiel

Application for a non-material amendment (1) following grant of planning permission

PA18 (03868 Amendments sought — Parn roof

PA18/02868. Amendments sought – Barn roof hips removed from NE and SW gable; use of cedral weather boarding instead of slate hanging; window on north-west elevation enlarged from 1200mm wide to 1800mm

wide.

It was **resolved** to support the change in size of the window and barn roof hips, but does not support the amendment to use cedral weather boarding. Lostwithiel's Neighbourhood Plan Paragraph HH2 subsection f states 'Layout for new development should be designed and constructed to a high standard, reflect existing scale and density of housing in the Character Zone, make sensitive use of local topography and avoid development on the skyline

surrounding the town. Design and use of materials within the conservation area must be in accordance with those of its Character Zone'.

- 3) No vehicles are parked across any vehicle exits from the parade area
- 4) Permission is granted for the stage to be set up and left in situ between events
