**Safer Cornwall Partnership Plan 2019-22 Consultation**

Safer Cornwall is the community safety partnership for Cornwall and has a responsibility to tackle crime, anti-social behaviour and other issues that impact on community safety. The Partnership brings together a wide range of public, community, voluntary and private sector organisations to do this, including the police, council, fire and rescue service, health and probation services.

This is Safer Cornwall's new partnership plan, which is planned to come into effect on 1 April 2019.

The plan sets out how we will tackle these issues over the next three years, focused on the priorities that we need to address to ensure that Cornwall is a safe, healthy and resilient place for the benefit of everyone who lives, works or visits here.

Your views are important to us and for the next three months, we are inviting you to read the plan and send us your thoughts about what you like about it, what you don't like and if you'd like to see any changes. We will then use all of this feedback to shape the final plan, which will be published in March 2019.
