501/11 LEAF LITTER PROJECT

Luci Isaacson thanked the Council for their support of the project. In three months the offenders collected three tonnes of leaf litter and over forty five offenders were involved. It is hoped that the programme will now be rolled out to Lostwithiel, Par and St Blazey.

502/11 PUBLIC PARTICIPATION

The Council was addressed regarding irresponsible parking in the Cattle Market car park particularly on Fridays and Sunday mornings. The Council was advised that residents have seen vehicles so badly parked that it would not be possible for the Fire tender to leave the Fire Station.

This vote resulted in a tie and it was proposed by Councillor Jones and seconded by Councillor May that a further ballot is conducted at next month's full Council meeting. This proposal received the support of the Council.

519/11 PLANNING FUTURE CORNWALL CORE STRATEGY

It was proposed by Councillor Mrs Parsons and seconded by Councillor Peareth that the Town Clerk is instructed to prepare the Town Council's response to the consultation based on the issues raised and that the Council delegates to the Planning Committee final approval of the wording prior to the submission to Cornwall Council. This proposal received the support of the Council.

520/11 SLCC

It was proposed by Councillor Jones and seconded by Councillor Stead that the annual membership is renewed. This proposal received the support of the Council.

521/11 ACCOUNTS & FINANCE

The bank account balances were reported to Council. It was proposed by Councillor Peareth and seconded by Councillor Mrs Wilkinson that cheques presented totalling £4024.28 are authorised for payment. This proposal received the support of the Council.

522/11 PUBLIC TRANSPORT

The Clerk was instructed to write a letter to Cornwall Council to express the Council's deep concern regarding the provision of bus services in Lostwithiel.

523/11 SNOW & ICE PLAN

The clerk updated Council regarding the following outstanding issues:-

The contractor does not envisage a problem working in the streets of Lostwithiel or refilling the Town's salt bins.

Cornwall Council will cover the Public Liability aspect of insurance for voluntary work on the public highway or footpath providing it is undertaken by volunteers who have attended the 'Winter Awareness Training for Town & Parish Councils and Community Groups' and that the snow clearance is carried out in line with Cornwall Council procedures.

It was proposed by Councillor Warwick and seconded by Councillor Peareth that the Council joins the snow and ice plan as soon as possible.

524/11 DIABETIC RETINAL SCREENING

It was proposed by Councillor Jones and seconded by Councillor Nicholls that the Royal Cornwall Hospital Treliske is allowed to site their screening unit in the Cattle Market car park from 15-23 March inclusive. This proposal received the support of the Council. Councillor Peareth offered to supervise the siting of the unit.

525/11 LOSTWITHIEL MUSEUM

It was proposed by Councillor Nicholls and seconded by Councillor Mrs Wilkinson that the Museum are granted permission to continue to have free use of the Guildhall for their meetings. This proposal received the support of the Council.

526/11 LOSTWITHIEL MUSEUM HERITAGE WALKS

It was proposed by Councillor Peareth and seconded by Councillor Sweet that Lostwithiel Museum are granted permission to use the Guildhall for their meeting on 16 February and granted permission to continue to access the Guildhall on their weekly walks from 5 April – 25 October 2012. This proposal received the support of the Council.

It was proposed by Councillor Mrs Jarrett and seconded by Councillor Parsons that permission is granted to Lostwithiel Rotary to change the display on the playing field on Sunday 15 July 2012 from sheep shearing to a farrier. This proposal received the support of the Council.

It was proposed by Councillor Peareth and seconded by Councillor Jones that permission is refused for the siting of a fun fair on the playing field during the Carnival week.

Bodmin Hill – is it possible to consider a one way traffic system

Pavement in Fore Street outside Lloyds TSB is a trip hazard.
