31/12 PUBLIC PARTICIPATION The Council was addressed regarding the Brunel Quay's wall.

33/12 DECLARATIONS OF INTEREST

34/12 COMMUNITY POLICE - Report

35/12 CORNWALL COUNCILLOR Report

Cornwall Councillor Shakerley updated the Council on his progress with South West Water regarding the Coffeelake access route and discussed the Town Council's request to refer the Restormel Lodge planning application to Cornwall Council's Planning Committee.

36/12 TO RECEIVE THE MINUTES OF THE ANNUAL MEETING OF THE COUNCIL

44/12 ANNUAL ACCOUNTS

The clerk advised Council that the accounts are still with the Internal Auditor. It was proposed by Deputy Mayor Mrs Jarrett that this agenda item and the previous Code of Conduct item are discussed at an extraordinary meeting on Tuesday 19 June 2012. This proposal received the support of the Council.

The bank account balances were reported to Council. After discussion, it was proposed by Councillor Abbiss and seconded by Councillor Jewels that cheques presented totalling £7799.55 are authorised for payment and that cheque 104268 for £1020 is also authorised. This proposal received the support of the Council.

49/12 LOSTFEST 2012

The clerk read to Council an email received on 15 May from Lostfest. It was proposed by Honoured Burgess Peareth and seconded by Deputy Mayor Mrs Jarrett that the clerk is instructed to reply to the organisers to thank them for all their hard work, congratulate them on a splendid day and suggest that the Lostfest Organisers and the Town Council start discussing arrangements for next year's festival as soon as possible. This proposal received the support of the Council.

50/12 SOUTH WEST WATER - LOSTWITHIEL STORM TANK

The clerk advised that South West Water have advised that at a recent meeting between South West Water and Coffeelake Meadow residents two requests were made.

- 1. To consider the use of the railway for delivery of materials, and perhaps removal of spoil, in association with Coffeelake Meadow as an access.
- 2. To revisit the use of Lostwithiel Industrial Estate as an access to come out by the level crossing, over it and then turning down into the goods yard for all site traffic.

The clerk was instructed to ask South West Water to ensure that the Council is regularly updated.

51/12 PUBLIC RELATIONS

It was proposed by Deputy Mayor Mrs Jarrett and seconded by Honoured Burgess Peareth that the Mayor writes a monthly report for the Cornish Guardian and the Cornish Times. This proposal received the support of the Council.
