133/23 Lostwithiel Community Centre – CCTV Grant Application

It was **resolved** to instruct the clerk to thank Lostwithiel Community Centre for their grant application and to ask them to supply more detail for example how the system will be set up, where the cameras will be located and how the Community Centre intends to meet Data Protection regulations.
