

Lostwithiel Town Council Meeting Tuesday 12 September 2023

Cornwall Councillor Report

Cornwall Councillor Martin advised the Council that Cornwall Council's Ecologist does not support the current Gillyflower planning application. Further application progress updates will be provided by CC Martin as soon as they become available.

Cornwall Councillor Martin also advised the meeting that Cornwall Council has a 'huge black hole' in their finances and going forward it will stop providing any services that it legally doesn't have to undertake.

CC Martin further advised that he has recently met with the Chief Executive of Cornwall & Isles of Scilly Integrated Health Partnership and raised the issue of the lack of NHS dentist provision in Lostwithiel. It is hoped that a pilot dentistry plan will be introduced in Lostwithiel.

CC Martin has been contacted by residents regarding the flattening of a hedge at Polscoe, this has been reported to Cornwall Council's planning enforcement team.

Finally, CC Martin answered a question regarding Tamar Bridge tolls and reminded those present that neither Plymouth City Council or Cornwall Council subsidize the bridge. All bridge running costs have to be covered by tolls.

141/23 Meeting Minutes 22 August 23

It was **resolved** that the minutes of the 22 August are accepted, approved and duly signed by Mayor Henderson. Vote 7 in favour, 4 abstentions.

142/23 Presentation of past Mayor's Badges

Mayor Henderson presented past Mayor's badges to former Mayor Tim Hughes and former Mayor Councillor Karen Ross.

143/23 Planning applications-

a)

PA23/05090-

Chy Forstor, Terras Hill, Lostwithiel Raise roof of dwelling and extend upwards to provide new first floor level, widen existing garage and construct a porch. Create a new access to Terras Hill and add further parking provision.

It was **resolved** to support this application subject to a recommendation that the roof height is reduced. Vote 8 in favour, 2 against & 1 abstention.

PA23/06107

Moorfield, Polmena Lane Lostwithiel Re-application from lapsed permission PA18/03361 – Construction of detached double garage, with ancillary accommodation (annex) above consisting of studio bedroom sitting space & WC/shower room with facilities shared with main dwelling. Finished with rendered and painted blockwork walls and natural slate pitched roof to match existing Moorfield building and slate tile hung gable ends (above eaves level).

It was **resolved** not to support this proposed development due to the site being highly visible from large parts of Lostwithiel. If as LPA Cornwall Council is minded to approve the application the Town Council requests that condition 3 of the approval for PA18/03361 namely:-

3 The first floor studio room above the garage shall be used as ancillary accommodation in association with the host dwelling (known as Polmena Bungalow) only and for no other purpose including any other purpose in Class C3 of the Schedule to the Town and Country Planning (Uses Classes) Order 1987, or any provision equivalent to that class in any statutory instrument revoking and re-enacting that Order.

Reason: The creation of an independent residential unit in this location would be contrary to the approved planning policies for residential development in the area and in accordance with the aims and intentions of Policy 7 of the Cornwall Local Plan: Strategic Policies 2010-2030 and the National Planning Policy Framework 2012, with particular reference to paragraphs 7 and 55. is included as a condition of any new consent given.

Vote 11 in favour.

PA23/06599

Land off Coffa Bridge Close, Coffa Bridge Close, Lostwithiel

Application for works to trees subject to a tree preservation order (TPO) namely: Poplar tree – reduce five lower-level branches. Poplar tree – clean cut torn branch stub and dead material from earlier storm damage. Oak tree -reduce one lower-level branch.

It was **resolved** to support this application. Vote 10 in favour, 1 abstention.

b) **PA23/04889**

Newham Park, Newham Lane, Lostwithiel Construction of dwelling in lieu approved barn conversion Class Q (amended design)

The Council Members who were present at the Council meeting held on 01 August considered this application under the 5-day Local Council Protocol. It was **resolved** to request that the application is considered by the Cornwall Council Planning Committee. Vote 5 in favour of Option 3 – to request the application is taken to Committee and 2 in favour of Option 2 to agree to disagree.

Lostwithiel Town Council does not support this application, the Council considers that the proposal will sit uncomfortably in the Area of Great Landscape Value and sets a precedent for the rest of the County.

Non material amendment in relation to decision notice PA19/11224 dated 12/05/21 changes to patio doors to plot 6,9 and 27 omitted and replaced with windows and raised terrace removed and replaced with patio at ground level. Car park 02 (spaces for plots 5-7)

Stone wall on top of RC retaining wall

omitted due to buildability issues and replaced with 1.8m high close boarded timber fence.

It was resolved not to submit any comments. Vote 11 in favour.

It was **resolved** to extend the King George V football pitch cutting regime to include the under 10's training, friendlies and 24-25 season league matches area and to review the use of this area and the revised cutting regime at the end of the 24-25 season (April 25). Vote 11 in favour.

145/23 Speed reminder sign for the A390 circa the Grenville Road junction It was resolved not to purchase a speed reminder sign for the A390 circa the Grenville Road junction. Vote 11 in favour.

148/23 The Parade Lostwithiel – vehicle weights

It was **resolved** to delegate to the Town Clerk the authority to agree to allow some vehicles to access the Parade for loading and unloading on a case-by-case basis. Vote – 11 in favour.

149/23 Tree inspection

It was **resolved** to approve £2500 plus Vat to undertake a tree safety survey on land owned/managed by Lostwithiel Town Council as detailed in the 2019 Tree management Policy. The price to include the fixing of tree tags to each tree. Vote 11 in favour

150/23 Lostwithiel Town Council Flood Plan

It was **resolved** to arrange a Flood Plan test event for Wednesday 11 October in Lostwithiel Library at 7pm. It was discussed that after this test event a further test event should be arranged without Cllr Ross in order to build capacity. It was further agreed that Flood Warden training should be arranged before Christmas if sufficient volunteers come forward.

151/23 Lostwithiel Community Centre – CCTV grant application
