

Lostwithiel Town Council Meeting Tuesday 06 February 2024

Cornwall Councillor Report

Cornwall Councillor Colin Martin addressed the meeting regarding Cornwall Council's annual budget setting.

Road to Lerryn – CC Martin advised that that it is not just a pothole, but a section of culvert under the road that has collapsed and this is interfering with the adjacent water course. It has had to be dug up and re-laid, work started last week and an email has been sent to request that the bollards formerly present to mark the passing bays are also reinstated.

Cornwall Councillor Martin also advised that the Gillyflower planning application is due to be considered by Cornwall Council's Strategic Planning Committee on 21st March 2024.
