512/12 TO RECEIVE AND ADOPT THE MINUTES OF 6 NOVEMBER 2012

517/12 REMEMBRANCE SUNDAY - COMPLAINT

It was proposed by Councillor May and seconded by Honoured Burgess Nicholls that the current commemoration arrangements continue and that the clerk suggests to the complainant that he may wish to contact the Royal British Legion Pall Mall London to ascertain their advice. This proposal received the support of the Council.

518/12 PLAYGROUNDS

It was proposed by Councillor Jewels and seconded by Honoured Burgess Jones that the Councils supports the proposed project and agrees to work in conjunction with local groups. This proposal received the support of the Council.

519/12 FLOODING – DRAFT LETTER TO RESIDENTS WITHIN THE RISK AREA It was proposed by Councillor Parsons and seconded by Councillor Mrs Bettin that the wording of the letter to residents is approved as drafted. This proposal received the support of the Council.

520/12 SNOW & ICE PLAN – ROAD SALT STORAGE

It was proposed by Deputy Mayor Mrs Jarrett and seconded by Honoured Burgess Nicholls that Lostwithiel Town Council accepts the offer from the Worshipful the Mayor of Lostwithiel Mrs Parsons to contact two local farmers to ask if they are able to store Town Council salt. This proposal received the support of the Council.

521/12 EDGCUMBE HOUSE – REPLACEMENT WATER & SEWAGE SYSTEMS It was proposed by Councillor May and seconded by Councillor Jewels that the clerk is instructed to contact four builders to ask them to price to construct a new water & sewage system for Edgcumbe House & that this system includes the insertion of a water meter for the Chapel building. This proposal received the support of the Council and Honoured Burgess Jones offered to assist the clerk in preparing the job specification.

522/12 BARN PARK/LIDDICOAT ROAD BIN

It was proposed by Honoured Burgess Peareth and seconded by Councillor May that the Council replaces the bin with a black and gold bin (similar to those currently around the town) and that the new bin is bolted to the seat. This proposal received the support of the Council.

523/12 LOSTWITHIEL ROTARY – PERMISSION TO USE KING GEORGE V FIELD & COULSON PARK

Councillors Jewels and May having previously declared pecuniary interests left the meeting room. It was proposed by Honoured Burgess Nicholls and seconded by Honoured Burgess Nicholls that Lostwithiel Town Council grants permission to Lostwithiel Rotary to use both King George V playing Field and Coulson Park for 2013 Carnival Week 21 -27 July 2013. This proposal received the support of the Council.

Councillors Jewels and May rejoined the meeting.

524/12 CORNWALL COUNCIL SEAGULL PROOF SACKS

It was proposed by Councillor May and seconded by Councillor Jewels that Lostwithiel Town Council does not participate in the Seagull/vermin proof sack scheme and that the clerk is instructed to respond to Cornwall Council advising that the sacks are too expensive. This proposal received the support of the Council.

525/12 ICE CREAM BIKE IN COULSON PARK

It was proposed by Councillor Jewels and seconded by Honoured Burgess Jones that Lostwithiel Town Council does not wish to grant permission to allow a catering facility in Coulson Park. This proposal received the support of the Council.

Honoured Burgess Nicholls having previously declared a pecuniary interest left the meeting room. It was proposed by Honoured Burgess Peareth and seconded by Councillor May that cheques presented totalling $\pounds 6203.90$ and an account transfer of $\pounds 8,000$ are authorised for payment. This proposal received the support of the Council.

Honoured Burgess Nicholls rejoined the meeting.

The clerk was instructed to notify Cornwall Council Highways of the following:-

Bank at the bottom if Bodmin Hill – as Highways are repairing the coping stones whilst on site would it be possible to please repoint the whole wall prior to frost.

A390 – Could Cornwall Council please confirm that the replacement of the cats eyes coming down Bodmin Hill is on their schedule of works for the A390.

Junction Lanwithan Road – Butts Park please remove mud and crushed leaves as they are blocking the drains.

Unclassified road from Bodmin Lodge – Bosmaugan Cross the road is breaking up to a depth of 6 inches Alleyway from Guildhall to South Street is very slippery and needs clearing.

The clerk was further instructed to write to Highways to thank them for their works on the new drains between Nomansland and Sweetshouse and for clearing the vegetation around the bollard on the junction.
