- 3. If more applications are received than vacancies to be filled, the Town Council will decide which of the applications is to fill the vacancy.

Qualification Categories

Regarding the arrangements for the filling of any vacancy where co-option applies, the Town Council may co-opt as a member any person who is legally qualified to hold such office, and who is willing to serve, provided he or she satisfies at least one of the following qualification categories: -

- (a) is registered as a local government elector for the parish;
- (b) has during the whole of the preceding twelve months occupied as owner or tenant, any land or premises in the parish;
- (c) his/her principal or only place of work during the preceding twelve months has been in the parish;
- (d) had during the whole of the preceding twelve months resided in the parish or within 4.8 km thereof.
