 The Brambles, Lostwithiel
 It was **resolved** not to support this application
 due to the following -
 - the impact the development would have on the active Section 106 agreement
 - that the area has been set aside as green space in Lostwithiel's emerging Neighbourhood Plan and is outside the

proposed Neighbourhood Plan development boundary, (the Cornwall Council proposed housing quota for Lostwithiel can met and exceeded within the proposed development boundary),

- the proposed site has access and parking difficulties,
- the proposed site is in a critical sewage and drainage area
- the proposed site poses safeguarding issues for the neighbouring school.

Polmena Bungalow, Polmena Lane Lostwithiel Construction of detached double garage with ancillary accommodation (annex) above It was **resolved** not to support this application, the proposal would be highly visible from the town, surrounding countryside and Moor areas. The proposed development is not in accordance with the emerging Lostwithiel Neighbourhood Development Plan and the Council considers, as an alternative that siting

a garage to the rear of the property would reduce the visual impact.
