## **Public Participation**

The Council was address regarding the following:

The relining of disabled bays in the Cattle market car park & the poor appearance of Lime Kilns.

Situ8 planning consultants addressed the meeting regarding planning application PA18/08552. They addressed three points raised by the Town Council in their consultee response.

- 1) The site is outside of Neighbourhood Plan Boundary. Situ8 consider that the development rounds off the boundary.
- 2) Situ8 are of the opinion that the number of extra traffic trips will be low and easily accommodated by the existing road access splays.
- 3) The Phase 1 ecology survey does not mention owls as the proposal has no impact on their nesting sites.
