261/18 Minutes 6 November 2018

264/18 Lostwithiel Railway Station Footbridge

Deputy Mayor Hughes advised Council that all content of the meeting he attended on 9 November is, at the current time, confidential. However, he was able to advise that after 8 years of asking, Cornwall Council and Network Rail finally seem to be taking the request seriously. Also, the only rail timetable changes in the whole of the country next May will be in Cornwall where there will be extra Penzance to Plymouth services.
