- 1. To receive and accept Apologies of Absence.
- 2. To receive any Declarations of Interest or written requests for new DPI dispensations from Members.

Members are invited to declare disclosable pecuniary interests and other (non-registerable) interests in items on the agenda as required by Lostwithiel Town Council's Code of Conduct for Members and by the Localism Act 2011.

- 3. Public Participation Time allowed for members of the public to address the Council on matters on the agenda Maximum time allowed 15 minutes
- 4. To receive the minutes of the extraordinary meeting held on 7 February 2019 having previously been circulated and taken as read.
- 5. To receive planning decisions
- 6. Planning applications to consider any applications received since publication of the agenda
- Licensing Application LI19_000399 Skylark Distillery Ltd, Couchs Mill Barn, Couchs Mill Lostwithiel – to consider the licensing application for the sale of alcohol for consumption off the premises Monday – Saturday 10am – 10pm Sundays 10am – 6pm.

- 8. Play area inspections to note the inspection reports and any action required.
- 9. Department of Transport Williams Rail Review to consider if Council wishes to appoint a task and finish group to draft, for Council approval, Lostwithiel Town Council's response to this consultation.
- 10. Ministry of Housing, Communities & Local Government Pocket Parks Plus scheme to note the following:
 - a) That due to the time constraints of the scheme the project price submitted was not obtained in accordance with Section 11 of Lostwithiel Town Council's Financial Regulations.
 - b) To note that if the Council's application is successful it is now not possible to comply with Section 11.2 of the Financial Regulations
 - c) To instruct the clerk to request prices from a further 5 firms to supply and fix play equipment and grass matting as specified in the application.
- 11. Cornwall Council Polling Districts & Polling Places review to note that by law Cornwall Council must conduct a polling district and polling places review every five years. The next review is due now and must be completed by the end of January 2020. In March 2019, every town and parish Council in Cornwall will be consulted and comments will be invited on the suitability of polling stations and voting arrangements at elections in their area. (The Polling District and Polling Places Review is NOT the same as the Community Governance Review. These reviews are completely separate and must

each follow a different legal process. However, Cornwall Council will be monitoring responses for both reviews for any crossover issues).

- 12. Cornwall Council Maintenance Partnership Invitation 2019 to consider if Lostwithiel Town Council wishes to join the scheme.
- 13. Lostwithiel Town Council Child Protection & Safeguarding Policy to consider approving the policy as drafted.
- 14. Lostwithiel Community Centre Committee to consider, in light of the recent Lostwithiel Newsletter article, the appointment of a Council representative to this Committee.
- 15. Grit bins to consider if Lostwithiel Town Council wish to replenish grit in the empty grit bins.
- 16. Town Council Allotment to authorise the removal of the asbestos sheeting at a cost of £294 plus VAT.
- 17. Lostwithiel Library to consider the following:
 - a) If the Council wish to continue to provide a copy of the Western Morning News & Cornish Guardian in the library.
 - b) If the Council wish to supply Council volunteers with coffee, tea, sugar, milk and biscuits.
- 18. Full Periodic inspection test and certificate of fixed wiring system to approve the cost of £720 plus Vat to inspect Edgcumbe House, the Guildhall (including the Museum office) and Lostwithiel Museum.
