# 138/19 Cornwall Council Community Network Panel Extraordinary Panel Meeting 9 September

Council discussed the information provided and considered that it was unable to make a decision until Cornwall Council's Localism team has

- a) confirmed the delegated powers given to the Community
   Network Areas
- b) clarified if the agenda item is consistent with the delegated powers given to the Community Network Areas.

Council considered the wording of the Community Network agenda item too vague and instructed the clerk to obtain clarification regarding the following: -

- a) Have the proposed areas been defined by road mileage or on an equal split of geographical area?
- b) Will there be a detailed set of criteria issued to the five areas within the Community Network Area regarding how the money can be spent?

It was decided to defer this agenda item for consideration on

either 20 August or 3 September dependant on the date of receipt of the requested information.

139/19 Climate Emergency resolution – task and finish group It was resolved to appoint a task and finish group to draw up an action plan for full Council consideration which will implement the resolution made under minute reference 110/19. It was further resolved to appoint Councillors Duffin, Guiterman, Hatton & Jarrett to this task and finish group. Councillor Hatton agreed to arrange the first meeting.

#### 140/19 Lostwithiel Rotary

- a) It was **resolved** to accept Lostwithiel Rotary's very generous offer of £1,500 for repair/replacement of the Town Notice boards with priority to be given to those on the Parade and in the Car park. The clerk was instructed to ask Lostwithiel Rotary if the money could be spent on a new noticeboard for the Parade and if their organisation has suitable Public Liability would they please consider erecting this noticeboard and the new Cemetery noticeboard.
- b) Councillor Duffin left the meeting room.

  It was **resolved** to thank Lostwithiel Rotary for ring fencing £350 for the Pendour Park play area and to instruct the clerk to advise Rotary that as soon as the current safety issues have been resolved the Council will be back in contact with Rotary regarding potential uses for the monies.

  Councillor Duffin re-joined the meeting.

#### 141/19 Public Toilet

It was **resolved** to instruct the clerk to reply to the email received by advising that the Town Council is very disappointed that the writer considers that Lostwithiel's gender neutral public toilet is not acceptable. Nationally there is an increase in provision to address the concerns of transgender people.

#### 142/19 Shire Hall Moor Crosses

It was **resolved** to instruct the clerk to follow the ICCM recommendations namely to erect a notice asking a family member to contact the Town Council office and leave this notice in place for two months. If nobody approaches the Council in that time, put up a further notice stating that the crosses will be removed and retained by the Council on xxx date and leave this sign in place for a minimum of one month.
