# **MEETINGS ATTENDED ON BEHALF OF THE COUNCIL**

- **111/10 Forum AGM** attended by Cllr. Pegg. The meeting was attended by 6 Board members and 7 members of the public. One new Director, Joe McUlian (arts portfolio). The Chairman reported future ideas for cycle trail from Bodmin to Lostwithiel, Slipway on Quay Street, and Bandstand in Parade.
- **112/10 Cornwall Association of Local Councils** attended by the Town Clerk. The meeting included information on footpaths and the current banding system. This has proved to be confusing and will be reviewed. Capping of Town and Parish Council precepts. It would appear that this will only apply to precepts of £500,000/£750,000. The Localism Bill will be published in November and capping is likely to dealt with in that.

- **113/10 Youth Forum** attended by Cllr. Stead. Due to a lack of interest Helen Taylor will now be a co-ordinator for events involving the various youth groups and only calling a meeting when there is an up-coming event. The meeting was attended by only Helen Taylor, Cllr. Stead and a representative of the Cubs. Cllr. Stead gave a comprehensive report on matters discussed, the Christmas tree, Victorian style lanterns in a procession in Fore Street on Dickensian evening and a stall manned by children during the food festival in half term week.
- **114/10 Localism Meeting** at Truro City Council attended by The Mayor and The Deputy Mayor. The purpose of the meeting was to explore if there is a willingness to present a united front to Cornwall Council with regard to actively working together. Most Councils were only concerned with their own areas. Nothing constructive came from the meeting but perhaps something will arise in the future.
- **115/10 Skateboard Ramp Agreement** annual renewal. It was proposed by Cllr. Peareth and seconded by Cllr. Stead that the Agreement be renewed for another year. All in favour.
- **116/10 Sale of foreshore land adjoining Old Quay Cottage.** This transaction is now complete and the Council has received the agreed sum of £4,500.
- Cllrs. Abbiss and Peareth left the room.
- **117/10 Scouts** request for funding. They will be contacted to see if there is a specific item they need. We would prefer to buy something rather than give an amount of money. Proposed Cllr. Jewels. Seconded Cllr. Sweet. All in favour.
- Cllrs. Abbiss and Peareth rejoined the meeting.
