- 6. Shire Hall Moor Crosses to consider in accordance with Standing Order 8a) and in light of the further information provided minute reference **249/19**.
- 7. Edgcumbe House & Guildhall Condition reports to consider in light of the reports received approving the recommendation from the Heritage Buildings Committee to authorise the following works on Edgcumbe House (reference codes taken from the report): -
  - A1 Repair leak in flashings of east Chimney and around west valley/chimney
