## **Cornwall Councillor Report**

Councillor Colin Martin reported on details of a meeting he attended with the Cornwall Council's Health Scrutiny Committee. There was a discussion on how to access signposting for health care in Cornwall. The 111-telephone service is meant to help people find the right place within the NHS. In the past it hasn't always been helpful, however Cornwall have developed this service and it is now much cohesive. If you need any NHS help (which isn't an emergency) 111 is the number you need to call.

Councillor Colin Martin advised the meeting that he would not be supporting the Town Council's request to take The Brambles planning application to Cornwall Council's Planning Committee.
