

Lostwithiel Town Council Meeting Tuesday 03 November 2020

Cornwall Councillor Report

Cornwall Councillor Colin Matin reported that he was looking forward to hearing the Councils views on planning application PA19/11224 St Bartholomew's Meadow which will provide much needed affordable housing in Lostwithiel. He also reminded Council that the proposed changes to the planning system, could mean that in the future new developments wouldn't need to include any affordable housing at all.

Cornwall Councillor Colin Martin also reported that Cornwall Council's Public Health team are doing a brilliant job of following up every single Covid case that is reported to them. However, only 15% of test results are being turned around in under 24 hours. He will be pushing at the Cabinet Meeting for Cornwall Council and local NHS to take over the testing as he feels that the national system is failing. Colin Martin also reported on a local outbreak in Lostwithiel and that he hopes that people are staying safe and doing everything they can to help protect the whole community.

Cornwall Councillor Martin stated with the upcoming lockdown this causes a lot of financial uncertainty. Over the October half term Councillor Martin used some of his Community Chest funding to provide free meals to children eligible for free school meals. Cornwall Councillor Martin advised that if the Government does not

provide free meals at Christmas, he will want to see Cornwall Council providing this service.

Cornwall Councillor Colin Matin has been chasing for an update on the footbridge at the railway station. He reported that the good news is that the bridge is going ahead and funding is in place and the delays are due to a significant amount of work/surveys are going on behind the scenes.

200/20 Planning applications

PA19/11224

Land known as Bartholomew Meadow,

Grenville Road, Lostwithiel

Reserved matters application for access, appearance, landscaping, layout and

scale, following outline approval PA18/05607 dated 13.08-2019 for the construction of 47 residential units to include affordable housing.

It was **resolved** to support this application in principle however the Council's support is dependent on the reinstatement of the tank for run-off water with a one way valve and the following being addressed:-

- a) Written scheme of investigation is provided to comply with Condition 4 of the outline planning consent namely Archaeology and a full report on the very old Oak tree.
- b) A full drainage strategy is prepared for the development. Rationale to alleviate the potential for run-off water to exacerbate the flood risk to properties further down and closer to the Town centre
- c) Serious consideration is given to putting a footpath into the town on the same side of the road as the housing development. Rationale is A390 is a very busy road to cross with young children
- d) The Police consultee comments are implemented
- e) The Principal Public Space Officer comments are implemented regarding the southern boundary of the development.
- f) The Section 106 education provision consultee comments are implemented
- g) The Highways condition to secure the access arrangement works including off site highways improvement measures, extending pedestrian footway/cycle path westwards between site and junction of B3268 is implemented
- h) To replace any Section 106 play area provision with Section 106 Highways provision to pay for a speed limit reduction from Downend through to Community Centre where the existing 30mph limit currently finishes. Rationale to make the road safer. Suggested amount £35,000
- i) A condition of the planning consent that these properties fulfil local affordable housing need i.e. affordable housing need for

Lostwithiel residents or people with an existing connection to Lostwithiel

Votes – 7 in favour, 3 objections.

It was **resolved**, having noted the comments from Highways, will not support this application unless the turning circle is reinstated.

201/20 Lostwithiel Town Council Budget 2021-22

It was **resolved** to accept the document as a first draft and to instruct the clerk to draw up a second draft which keeps the precept the same as last year. This revised draft should include the equivalent of 4 months of precept in general reserves.

Votes – 10 in favour, 1 unable to vote (IT problems).

202/20 Covid 19 risk assessments

It was **resolved** not to make any changes to the Town Council's Covid19 risk assessments with the exception of the Outdoor Gym which will need to close with effect from 05 November in line with Government Guidance.

It was **resolved** to approve that the existing scheme of delegation extends to all facilities for the duration of the pandemic, with the proviso that decisions are taken based on Government advice and that this scheme of delegation has the full support of the Council. It was further **resolved** to approve £208.85 plus VAT for signs for the Outdoor Gym.

Votes – 11 in favour.

203/20 Remembrance Sunday

It was **resolved** to not be invite wreath bearers from Town organisations to lay their wreaths at the War Memorial and that all wreaths will be laid by Mayor Hughes, Revd Beynon and Royal British Legion representative Mr John Henderson. The short wreath laying ceremony will be recorded and made available on Lostwithiel social media sites before 11am on Remembrance Sunday.

Votes – 11 in favour.

204/20 Parade – Pop up table

It was **resolved** to refuse a request to hold a pop-up Christmas table top sale in November due to the lockdown. However, the Council will reconsider this decision if the organisation puts in a new application if circumstances change in December.

Votes – 11 in favour.

205/20 Parade - Christmas tree

It was **resolved** to approve the request from Lostwithiel Rotary for consent to erect a 20ft Christmas tree with fencing on the Parade with the provisos that the lighting is checked prior to switch on by an approved electrician and that Lostwithiel Rotary arrange regular inspections of the tree and lights. The permission to erect the tree is valid from the end of lockdown

Votes – 10 in favour, one against.

It was further **resolved** to accept the offer of the festoon lighting on the Parade but not the erection of a stretch tent. The lighting is accepted with the provisos that it is checked prior to switch on by an approved electrician and that Lovely Projects will arrange regular safety inspections.

Votes − 10 in favour, one against.

206/20 Christmas Tree festival

It was **resolved** to approve request to take part in this year's St Bartholomew's Christmas Tree Festival at a cost of £14.00 and that Deputy Mayor Ross will decorate the tree, in line with Covid19 restrictions.

The Council was addressed by Mayor Hughes regarding the River Fowey bridge replacement.
