#### **Cornwall Councillor Report**

#### 216/20 Declarations of Interest

Mayor Hughes again declared in the interest of openness, that he has been appointed as the Conservative candidate to stand in next May's Cornwall Council elections. Mayor Hughes also declared a non-registerable interest in Agenda Items 10 and 11 - River Fowey Railway bridge works ask he has helped RW Rail select accommodation in Lostwithiel for the construction workers.

#### 217/20 Public Participation

Martin Butler (Site Manager) from R & W Rail addressed the Council regarding Agenda Items 10 and 11 - River Fowey railway bridge. Martin explained that the project and advised that works are currently to create a haul road for the crane needed to lift the bridge sections. The bridge lift is planned for the week beginning 13 March 2021 and the rail line will be out of action for 10 days.

Martin is attending the meeting tonight as some trees need to be removed or cut down in size as the bridge sections, due to their size, have only one route available. There is one tree in Coulson Park that needs to be reduced in size.

The entrance to Lanwithan Farm will be closed at Grenville Road from Thursday 10 December 2020.

It was **resolved** to resubmit the comment made by the Town Council in response to Planning Application PA19/11224. The Town Council has recently updated the play areas in Coulson Park, King George V playing field and Pendour Park. The Council would therefore, as previously advised, like to request that the Section 106 play provision is replaced with Section 106 Highways provision to be used to pay for a speed limit reduction from Downend through to the Community Centre where the existing 30mph limit currently finishes.

The Town Clerk asked all Councillors to relay any public comments to her regarding the bridge works.

# 224/20 River Fowey Railway bridge works

It was **resolved** to approve the request received for a small compound (approximately 10m x 10m) in Coulson Park close to the bridge for the duration of the works and to appoint a land agent specifically David Maskell of Jefferys Lostwithiel to negotiate on behalf of the Council regarding the compound and any Community Benefit monies that maybe available from Network Rail or their contractors or both.

Votes – 8 in favour.

# 225/20 Cornwall Council Town Centre Revitalisation Fund (TCRF) It was resolved to authorise the Heritage Buildings Committee to undertake the following -

a) Facilitate the creation of a cross sector 'town team'.

- b) Draft a strategy/emerging plan for the revitalisation of the town centre (either in whole or part)
- c) Draft Lostwithiel's application
- d) Provide monthly progress updates to Full Council
- e) Submit the final application to Full Council for approval prior to submission to Cornwall Council noting that the closing date for applications is 31 March 2021.

Votes – 8 in favour.

**226/20 Lostwithiel Town Council Heritage Buildings Committee** It was suggested that the invitation to fill the vacancies should be extended to other Members of the Council that were not present at this meeting.

#### 227/20 Lostwithiel Community Centre grant application

It was **resolved** to approve the Lostwithiel Community Centre grant application for £1,700 with the proviso that the full cost of the replacement boiler is taken from the Town Council's proportion of the grant funding. The Town Council should order and pay for the boiler as it would be possible for the Council to claim back the VAT. It was decided that the boiler to be purchased should have an A Energy rating and to acknowledge that this grant application has been approved due to exceptional circumstances in which two boilers have broken down at the same time.

Votes – 8 in favour.

# 228/20 Mount Pleasant Place

It was **resolved** to thank the member of the public for their letter and kind intentions and to ask them to contact Ocean Housing/Cornwall Council as the land owners for permission to make a 'children's garden'. It was further resolved to ask the member of the public to apply for a grant from the Town Council once they have been able to gain permission from the land owner to make a 'children's garden'.

Votes – 8 in favour.

#### 229/20 Free Dementia Help Point Network

It was **resolved** to join the Free Dementia Help Point Network when Lostwithiel Town Council is able to reopen the Library.

Votes – 8 in favour.

#### 230/30 Local Maintenance Partnership 2021-2022

It was **resolved** to thank the Local Maintenance Partnership for their invitation, but to decline the invitation to join the scheme. Votes – 8 in favour.

#### 231/20 Parade

It was **resolved** to approve the request received to hold a pop-up Christmas table top sale on Saturday 12 December from 10am – 12noon on the Parade subject to the correct insurance documents being provided and that the set-up of the table must be in line with current government Covid 19 regulations. It was further resolved to waive the £50 fee.
