HBC034/20 Cornwall Council Town Centre Revitalisation Fund Application

The Committee considered the second draft of the Heritage Buildings application and the first draft of the transport-based application prepared by Michelle Nineham and the feedback received from Cornwall Council's Fund Application team. It was decided that a copy of the Heritage buildings pre-feasibility report and the report to Council should be submitted as part of the Heritage Buildings application along with a concise report of the all the venues visited. Michelle agreed to prepare a further draft, based on the discussion and feedback, in time for the next Committee meeting and John agreed to draft a revised version of the transport-based bid. It was decided that this bid should include evidence from local businesses regarding the problems with parking, how this limits 'destination' marketing and how the number of parking spaces, speed of traffic,

The Committee felt that the applications needed to be prepared on a 'twin track' rather than 2 stage process.
