#### 031/21 Appointment of Consorts

#### 040/21 Covid 19 risk assessments

The Town Clerk give a verbal report regarding the risk assessments. It was **resolved** that no changes are currently required to the Covid 19 Risk Assessments.

## 041/21 Cornwall Community Flood Forum Property Flood Resilience Workshops

It was **resolved** to give permission for representatives of Lostwithiel's Flood Plan (Co-ordinators & Wardens) to attend, participate and present at the CCFF summer workshops.

Votes – 8 votes in favour.

### 042/21 Cornwall Council Town Vitality bids

It was **resolved** to invite Mayor Ross, Councillor Guiterman, Professor John Scott and Michelle Nineham to meet with Cornwall Council Officers to view the buildings and discuss the bids submitted on 16 June 2021.

Votes – 8 votes in favour.

## 043/21 Allotments

It was **resolved** to ask the contractor to install a length of timber under the gate for the gate to close against to make the gate area more rabbit proof. It was **resolved** to instruct the Town Clerk, with the benefit of photos supplied by Councillor Guiterman, to check if the rabbit-proof fence, as per the tender document, had been galvanised after weaving. It was **resolved** to allow the Town Clerk to approve the allotment contract if the fencing was galvanised after weaving. However, if it transpires that this was not the fencing used then the contract should not be signed off and the contactor should

be asked to replace the fencing with the specified galvanised after weaving fencing.

Votes – 8 votes in favour.

#### 044/21 Cemetery extension

It was **resolved** to accept the price received £2330 plus VAT to remove and dispose of the old wooden post and rail fence, grade the bank around and remove any old stumps without damaging the existing tarmac surface, rotavate/harrow the ground to provide a good depth for seeding, stone pick all stone and sow a suitable grass mix to the surface.

### 045/21 The Parade Lovely Projects stretch tents

It was **resolved** to instruct the Town Clerk to allow Lovely Projects to provide training to put up the stretch tent and to allow the stretch tent to be put up on or after the day that coronavirus restrictions (that allow for the events) have been lifted.

Votes – 8 votes in favour.

## 046/21 Hire of Town Council land

It was **resolved** in accordance with Standing Order 3f) to allow Michelle Nineham to address the Council in order to answer questions.

Votes – 8 votes in favour.

Michelle Nineham answered questions from the Council.

It was **resolved** to ask Michelle Nineham to resubmit the application for the Hire of Town Council form for the Town Council meeting on 15 June 2021. The Council asked that Lovely Projects contact local pubs regarding their plans and that the project should perhaps consider moving the events to a Thursday evening instead of a Friday evening.
