#### 055/21 Minutes 01 June 2021

#### 056/21 Planning applications

PA21/05318 Land known as Bartholomew

Meadow Grenville Road Lostwithiel

Modification of existing S106 Agreement dated 30 July 2019

relating to PA19/11224 to increase

the affordable housing being

homes.

It was **resolved** to support the modification of the existing S106 with the following provisos -

- a) The money is paid direct to Lostwithiel Town Council on the understanding that it is earmarked for the purchase of play equipment
- b) Lostwithiel Town Council has the discretion to decide what is purchased and in which Lostwithiel Town Council play area the equipment is located.

#### 057/21 Safe38

It was **resolved** that Councillor Wisdom will represent Lostwithiel Town Council at Safe38 campaign group meetings if required. Votes – 7 votes in favour.

#### 058/21 Hire of Town Council land

It was **resolved** to approve Really Lovely Projects application to hire the Parade for the summer (as soon as Covid restrictions are lifted) at no charge to Really Lovely Projects. As part of this application it was agreed that Really Lovely Projects will be able to hire the Parade (via an online booking system – with no hire fees) to Lostwithiel based non-profit organisations. Really Lovely Projects will ensure that anyone wishing to hire the Parade adheres to all the Town Council site specific requirements i.e. no vehicles on the Parade. Voting – 6 votes in favour, 1 against.

#### 059/21 Coulson Park Railway Bridge compound

It was **resolved** that the Council wishes to reaffirm that the area of the compound is reinstated to grass.

Votes – 7 votes in favour.

#### 060/21 Coulson Park Railway bridge aesthetics

It was **resolved** to defer this agenda item until further information is provided by Network Rail.

It was **resolved** approve the Fixed Asset Register as drafted.

Councillor Guiterman, having previously declared a non-registerable interest left the meeting room.

It was **resolved** to further discuss the clearing of the allotments by volunteers after the Council has received the allotment clearance proposals from the existing allotment holders.

Voting – 7 votes in favour.
