The Town Clerk read the emailed report which covered the period 1st-23rd February. 11 crimes of which 2 were detected. Two of the Town's most frequent trouble makers have been issued Stage 2 Antisocial behaviour letters and another is being considered for a Stage 1.

- Libraries. None due to close. Lostwithiel Library hours have been increased and the times/days varied slightly.
- Granites in South Street not as they should be. Keep monitored.
- Cornwall Council Budget has been accepted.
- St. Winnow snow and ice plan has been given Highways approval.

- **29/11 Lands & Parks 15th February.** An amendment was made to show that Deputy Mayor Cllr. Robson was in attendance. The Minutes were then approved and adopted and signed by the Deputy Mayor. Proposed Cllr. Mrs. Parsons. Seconded Cllr. Jarrett. All in favour.
- **30/11 Town Plan 23rd February.** The Minutes were approved and adopted and signed by The Deputy Mayor. Proposed Cllr. Warwick. Seconded Cllr. Watkins. All in favour.

MEETINGS ATTENDED ON BEHALF OF THE COUNCIL

- **31/11 Community Network Meeting 22nd February** attended by The Mayor and The Town Clerk. The main item of interest was from Cornwall Council on Double Taxation. However, nothing has changed and they will not be reinstating the grant.
- **32/11 Lostwithiel School Governors' Meeting** attended by Cllr. Mrs. Wilkinson 9th February. Government is looking to reduce funding to schools and they will be asked to attain Academy status.
- 33/11 Standing Orders and Financial Regulations. As discussed at the June meeting (52/10) new model standing orders have been issued by NALC and it was agreed that our amendments discussed in May (42/10) should be incorporated in the new document. The town Clerk reported that she has completed the update of Financial Regulations and is two-thirds of the way through Financial Regulations but has been unable to arrive at completion due to other matters needing higher priority. They will be completed as soon as possible and in the meantime the existing standing orders will continue to be used.
- **34/11 South Street replacement granites.** Cllr. Jewels reported that no attempt has been made to match the granites which needed replacement after the floods. He thanked Cornwall Councillor Shakerley for commenting on this earlier in the meeting. He suggested a letter is sent to the Conservation Officer expressing concern and asking if they could comply with the regulations and use granites which are in keeping with the area. Proposed Cllr. Jewels. Seconded Cllr. Pegg. All in favour.

It was proposed by Cllr. Warwick and seconded by Cllr. Mrs. Parsons that Cllr. Jewels remained in the room.

35/11 Rotary Carnival Week
