HBC009/21 Cornwall Council Town Centre Revitalisation Fund Applications – Draft responses to Cornwall Council

- a) Transport bid Lostwithiel Sustainable Traffic & Travel Plan It was **resolved** to recommend to the Town Council that the following wording is submitted to Cornwall Council 'Thank you for your feedback on Lostwithiel's application we are in agreement with everything written. Therefore, we would like consent to proceed to draft the tender for approval by the Town Vitality Team on the basis outlined. Whilst writing could we please formally request an extension to our project deadline from 31 December 2021 to 30 June 2022 with an option to extend to 31 December 2022 if Covid restrictions are reinstated.'
- b) Lostwithiel Heritage Buildings It was **resolved** to recommend to the Town Council that the following wording is submitted to Cornwall Council 'Thank you for your feedback on Lostwithiel's application we are in agreement that an assessment/demand study to identify potential uses and users of our buildings needs to be undertaken. In order to reinstate some momentum to the regeneration project we would be grateful if Cornwall Council would consider allowing Lostwithiel TC to incorporate this element into the feasibility study allowing the successful tenderer to adopt a two phased approach to the delivery of the feasibility study. In our original application we anticipated a proposed completion date of 01 February 2022, could we please formally request an extension to this date from 01 February 2022 to 01 August 2022 with an option to extend to 01 February 2023 if Covid restrictions are reinstated. Our Heritage Buildings Committee which incorporates Town Team membership have returned to face to face meetings and intend to meet on a monthly basis going forward.'
