185/21 Remembrance Sunday 2021

The Town Council discussed reinstating arrangements as pre-covid. It was suggested that the veterans should leave the church first this year.

Councillor Henderson left the meeting.

It was **resolved** to approve a cheque for £150 for the Royal British Legion Town Council's Wreath.

Voting – 9 votes in favour and 2 abstentions.

Councillor Henderson re-joined the meeting.

186/21 Remembrance Sunday 2021

It was **resolved** to approve the request received from 169 (St Blazey) Sqn RAF Air Cadets to join Lostwithiel's Remembrance commemorations.

Voting – 11 votes in favour and 1 abstention.

Councillor Jarrett left the meeting.

187/21 Lostwithiel Community Centre

A motion to support the grant application was defeated.

Votes – 2 votes in favour, 9 votes against.

It was **resolved** not to support the grant at this time, but to ask for more information from the Community Centre. It was **resolved** to

- a) ask the Community Centre to look at alternatives to gas for the boiler and to provide more detail on the boiler replacement quotations provided,
- b) to provide more information on the charging structure of the Community Centre to get a better understanding of why not all community groups can afford the community centre.
- c) the Town Council is happy to look at partial support of a new electric boiler system (at the next meeting of the Town Council) if the information can be provided by the Community Centre in advance of the meeting in writing to the Council Meeting to allow sufficient time for the information to be circulated.

Votes – 12 votes in favour.

Councillor Jarrett re-joined the meeting.

188/21 Pill Walk potholes

It was **resolved** not to approve the siting of 5mph signs on Pill Walk. Votes- 6 votes in favour, 3 against and 2 abstentions.

It was **resolved** to ask South West Water to look into the cost of repairing the path at Pill Walk on more than a temporary repair basis and to discuss exploring the option of a joint venture to repair the

path with a better surface to include the installation of 'sleeping policemen'. Votes – 8 votes in favour, 1 vote against and 2 abstentions.

189/21 Station parking

It was **resolved** to write to Cornwall Council on behalf of the resident.

190/21 Parade Beech tree stump grinding

It was **resolved** to approve the cost of £625 plus VAT to grind the stump to below ground level and remove arisings.

Votes – 8 votes in favour, 2 votes against and 2 abstentions.

192/21 Forest for Cornwall Landmark Tree Project

It was **resolved** to purchase a protective cage for the sapling for the cost of up to £250.00. It was further **resolved** that Councillor Rawlings would dig the hole and Councillor Guiterman would oversee the planting.

It was **resolved** to allow a pop-up Christmas table top sale on 06 November to fund raise for Guide Dogs. It was **resolved** not to charge the Guide Dogs charity for the hire of the Parade. Voting – 11 votes in favour, 1 vote against.
