# **HBC027/21 Cornwall Council responses**

a) Transport

The Committee considered the response relating to the transport bid and **resolved** the following: -

- ii) To submit the second draft of the project brief to Cornwall Council for feedback.
- iii) To accept Cornwall Council's offer of a separate offer letter for this project and to apply for the grant funding letter only after a response to i) & ii) have been received. (Rationale – to maximise the timeframe available)

It was **resolved** to accept Option 1 put forward by Cornwall Council on the basis that as Edgcumbe House and Taprell House are interlinked they are treated as one entity.
