# PA11/08747 19B North Street Lostwithiel Cornwall

Proposed demolition of semi-derelict house and the erection of new semi-detached three bedroom houses with integral garages.

It was proposed by Honoured Burgess Peareth and seconded by Councillor Abbiss that the Committee does not support this application as the proposed development is considered too large for the site area. This proposal received the support of the Committee.

# PA12/00636 Tregarth Victoria Lostwithiel, Cornwall

Demolition of existing bungalow and garage. Construction of new two-storey dwelling and separate single storey garage.

# PA12/00637 Tregarth Victoria Lostwithiel, Cornwall

Conservation Area Consent for demolition of existing bungalow and garage. It was proposed by Honoured Burgess Peareth and seconded by Councillor May that the Committee supports this application. This proposal received the support of the Committee.

### PA12/01106 Lanwithen View Lostwithiel, Cornwall

#### PA12/01250 12 North Street Lostwithiel, Cornwall

Conversion of redundant live/work building to a two-bed dwelling.

It was proposed by Honoured Burgess Peareth and seconded by Councillor Abbiss that the Committee supports this application. This proposal received the unanimous support of the Committee.

# PA12/01257 Restormel Lodge Hotel 7 Castle Hill Lostwithiel Cornwall

Construction of three bedroomed dwelling and integral parking. Resubmission of PA11/00935

It was proposed by Councillor Parsons and seconded by Councillor Abbiss that the Committee does not support this application. The size of the development is considered inappropriate for the size of the plot. The proposed development would be in close proximity to 2 Castle Hill and windows would overlook the property opposite. The proposed development would block visibility of the highway when exiting Castle Hill and an existing access has been blocked and an unofficial access has been made for vehicle entrance

This proposal received the unanimous support of the Committee.
