### **TOWN COUNCILLOR VACANCY**

NOTICE IS HEREBY GIVEN that pursuant of Rule 8 of the Local Elections (Parishes and Communities) Rule 1986, Lostwithiel Town Council has a vacancy arising by way of co-option.

1. If you are interested in becoming a Town Councillor, please submit a written expression of interest to the Town Clerk at the address below by **Tuesday 25 October 2022**. Please include a short personal statement giving reasons why you are interested in joining the Town Council together with a summary of your background and skills that you can offer the Council.
2. Candidates will be requested to attend a Council meeting on **Tuesday 01 November 2022** at 7pm in Lostwithiel Library and will be asked to address members regarding their application.
3. If more applications are received than vacancies to be filled, the Town Council will decide which of the applications is to fill the vacancy.

## Qualification Categories

Regarding the arrangements for the filling of any vacancy where co-option applies, the Town Council may co-opt as a member any person who is legally qualified to hold such office, and who is willing to serve, is a British or a citizen of the Commonwealth or European Union, 18 years old or over and meets at least one of the following qualification categories: -

- a) is registered as a local government elector for the parish
- b) has during the whole of the preceding twelve months occupied as owner or tenant, any land or premises in the parish;
- c) his/her principal or only place of work during the preceding twelve months has been in the parish;
- d) has during the whole of the preceding twelve months resided in the parish or within 4.8km thereof.
