Outline Planning Permission with all matters reserved except access for development for up to 6 houses

including associated works

It was **resolved** to support this application. However, based on local knowledge the Council wishes to highlight to the Local Planning Authority that it does not consider the Suds flooding measures are sufficient to mitigate run off from this site. The Town Council would ask the LPA to consider making a surface water storage tank a condition of planning approval. The Town Council wishes to also request that the LPA considers making the mitigation measure on Page 31 of the Statement Heritage a condition of planning. 'We would recommend that any programme of archaeological work seeks first to further explore the potential of the site through a programme of metal detecting and geophysical survey to prospect for scatters of shot relating to the 1644 skirmishes and prehistoric archaeological features respectively.' Furthermore, the Town Council's preference for this site would be for mixed housing as endorsed by paragraph 60

in the Lostwithiel Neighbourhood Development Plan. Finally, the Town Council would like to request that a copy of the Cornwall Council Highways report when available.

The Town Council is of the opinion that the proposal is not in accordance with aspects of the National Planning Policy Framework, Cornwall Local Plan policies 1, 2a, 7 & 21 and Lostwithiel Neighbourhood Development Plan HH3.

It was **resolved** not to support this application. The Town Council does not consider the proposal is in accordance with Lostwithiel Neighbourhood Plan Policy HH5 and would ask for a copy of the Phase 1 preliminary assessment for land contamination to be forwarded when received.

152/22 Lostwithiel Remembrance Sunday Parade

The clerk advised Council that arrangements are in place to borrow all the signs required for the Remembrance Parade from Cormac. It was **resolved** to reply to Rev Beynon to advise that the Council will keep the issue under review and that Councillors Guiterman, Guy & Kent and Mrs Guiterman will help Sandra & Claire with the road closure on the day.

153/22 SAAA 2022 Opt out

It was **resolved** not to opt out of the SAAA central external auditor appointment arrangements.

Votes – 10 votes in favour.

154/22 Mayor for Cornwall

It was **resolved**, given Cornwall Council's current position that Lostwithiel Town Council does not wish to formulate a response. Votes – 10 in favour

155/22 Allotments

It was **resolved** to accept the contractor's recommendation namely to mow off the plots and to continue to cut monthly to prevent seeding and to review again in December to check how many New Field plots remain unallocated.

156/22 Lostwithiel Public Toilet

It was **resolved** to note that the price approved on 02 August 2022 includes a timer but does not include a pay mechanism. It was further noted that the new timer mechanism needs to be compatible

with sensor lights, a slow closing arm and a more robust lock as the current lock is not fit for purpose. Votes – 10 votes in favour.

157/22 Broken bins

It was **resolved** not to replace the bin on the parade and to replace the bin at Second Island and outside the school at Bodmin Hill with Glasdon Jubilee 110 litter bins purchased with keys and 4 aperture blankers per bin at a cost of circa £550 per bin plus VAT. The removal of the bin at the Parade to be reviewed in six months to ensure that it has not resulted in increased litter in the area. It was also **resolved** to instruct the clerk to check the minutes for any pending bin orders and to ensure that these orders are also fulfilled with Jubilee 110 bins with aperture blankers to reduce the ability of seagulls to access and spread the rubbish.
