A written report was received from PCSO Natalie Phillips which advised that there have been 30 crime logs for October.

213/11 CORNWALL COUNCILLOR Report

Cornwall Councillor Shakerley advised that Cornwall Council's cabinet has approved a draft budget which will now go to the Scrutiny Committees. Cornwall Council's strategy is a four year programme and at the end of Year 1 seven million pounds of savings have been made.

On a local level the Central Cornwall Action Group Committee is encouraging new applications for funding for community projects from April 2012.

Cornwall Councillor Shakerley also advised that he is personally committed to trying to retain as many Cornwall Council public toilets threatened with closure as possible.

The bank account balances were reported to Council. It was proposed by Councillor Pegg and seconded by Councillor Mrs Parsons that the cheques presented totalling £5518.68 are authorised for payment. This proposal received the support of the Council.

229/11 FLOOD PLAN

It was proposed by Councillor Jewels and seconded by Councillor May that Lostwithiel Town Council adopts the Lostwithiel Flood Management Plan. This proposal received the unanimous support of the Council. Mayor Robson thanked Councillor Pegg for all his hard work on the plan. It is hoped that now the plan is in place it will be easier to recruit flood wardens.

230/11 DUCHY PALACE RENOVATIONS

The Council discussed the email received from Simon Thorpe. It was decided that the meeting with the developers would be arranged for Friday 11 November at 11.30am at the Town Clerk's office.

231/11 COUNCILLORS SURGERIES

After discussion it was proposed by Councillor Mrs Parsons and seconded by Councillor Pegg that Councillors should continue monthly surgeries. This proposal received the support of the Council.

232/11 PRESS POLICY

It was decided that this agenda item should be deferred until the December monthly meeting to allow sufficient time to consider the wording and to consider Councillor Warwick's suggestion to set up a press sub-committee.

Council decided that every effort should be made to keep the only set of public toilets in Lostwithiel open. The letter was referred to the Corporate Properties Committee to formulate a response to Cornwall Council.

This proposal received the support of the Council.

It was decided by Council that the Mayor's Parlour should be opened for the Dickensian Evening again this year. The Parlour should be 'manned' by two Councillors at all times and visitors should be encouraged to have refreshments after being in the Parlour.
