247/22 Apologies of Absence

249/22 Public Participation

The Council was addressed regarding Lostwithiel Twinning Association's French exchange visit on the weekend 19-21 May when Lostwithiel will be hosting. The Town Council was invited to host a reception for the visitors during this weekend and invited to attend a Twinning Association meeting on Monday 16 January. 251/22 Planning applications

a)

PA22/07134 & PA22/08659

Newham Park, Newham Lane, Lostwithiel Proposed construction of a dwelling (in lieu of approved barn conversion Class Q) with access, parking and landscaping and other associated development.

It was **resolved** not to support this application as the dwelling design is not as submitted under PA22/08659.

Votes – 10 in favour, 2 against.

252/22 Taprell House fireplace leak

It was **resolved** to authorise the cost of a Scott & Co visit to assess the water ingress via the fireplace and to approve the cost of works recommended by the surveyor without further reference to Council noting that if the works identified are significant then only a temporary repair will be undertaken.

Votes – 12 in favour.

253/22 Publication of draft minutes

It was **resolved** to publish draft copies of Council and Committee minutes on the Council's webpage clearly annotated 'draft copy' as and when office staffing allows.

254/22 Parade lights

It was **resolved** not to remove the lights but to arrange for the cobra system and the lights to be assessed and checked for failings as soon as possible. The Council's objective is to keep the lights up permanently on a timer switch to ensure they are not on during the day. It was further **resolved** to take responsibility for the lights if requested by Really Lovely Projects.

It was **resolved** to maintain the existing width of the entrance gateway and approve quote Option 1 at a cost of £410.00 plus VAT. Votes – 12 in favour
