It was further **resolved** to request the amendments of the Statement of Internal Control under section 3.3 and to make the aims and objectives of the Council a future agenda item and to add to the Risk Management table sections to cover the toilets, flood wall and Council trees. It was further highlighted that Council should consider bank accounts which pay better rates of interest.
