PA12/10815 19b North Street, Lostwithiel

Proposed demolition of semi-detached house and the erection of new semi detached two bedroomed houses.

It was proposed by Honoured Burgess Peareth and seconded by Honoured Burgess Jones that Lostwithiel Town Council does not support this application. The site provides inadequate parking for the proposed properties, inadequate surface water drainage and

the two proposed properties will further stretch the capacity of an overloaded sewage system. The Town Council would prefer replacement with a single dwelling with the same footprint as existing. This proposal received the support of the Committee.

#### PA12/11097 Colona Rose Hill Lostwithiel

Erection of new dwelling and integral garage.

It was proposed by Councillor May and seconded by Honoured Burgess Jones that Lostwithiel Town Council does not support this application. The design of the proposed property is completely out of character with the street scene and the Council would wish to express particular concern regarding the use of zinc roofing materials and cedar cladding. This proposal received the support of the Committee.

#### PA12/11661 15 Trewithan Parc Lostwithiel

Alteration and extension to dwelling.

It was proposed by Honoured Burgess Peareth and seconded by Councillor May that Lostwithiel Town Council supports this application. The proposal is considered' in keeping' with existing extensions in the area. This proposal received the support of the Committee.

#### PL592/12 CORRESPONDENCE

The Committee also discussed a letter regarding proposed changes to the Gilbury Hill development. The clerk was instructed to respond that 'the Committee have had an opportunity to look at the revised design and wish to raise no current issues at this time and await the receipt of revised plans from Cornwall Council in due course.'

## PL593/12 FLOOD WARDENS

The Committee discussed the arrangements for Thursday's flood meeting. The meeting will be attended by Charles Richards from St Blazey who will discuss the high visibility clothing available and Guy Herrington from the Fire Service who will talk to the Flood Wardens about safety during a flood incident. It was proposed by Councillor Pegg and seconded by Councillor May that the Council purchases Flood Timetables for the Flood Wardens. This proposal received the support of the Committee.

#### PL594/12 FLOODING – DEFRA FLOOD RESILIENCE COMMUNITY PATHFINDER

The Committee was advised that a Cornwall based application may be going to be made to this scheme. In preparation for a successful Cornwall based bid it was proposed by Honoured Burgess Peareth and seconded by Councillor May that Councillor Pegg and the town clerk prepare a list of eligible requirements for Lostwithiel for approval by the Committee at the February meeting. This proposal received the support of the Committee.

## PL595/12 COMMUNITY CHEST FUND

It was proposed by Honoured Burgess Jones and seconded by Councillor Abbiss that Lostwithiel Town Council submits an application to Cornwall Councillor Shakerley for £300 towards the provision of Flood Warden 'grab bags'. This proposal received the support of the Committee.

#### PL596/12 QUAY STREET – FLOOD SIGNS

It was proposed by Councillor Abbiss and seconded by Mayor Mrs Parsons that a moveable flooding sign for Quay Street is included in Lostwithiel's list under minute reference PL594/12. This proposal received the support of the Committee.
