PL786/12 Flooding

Honoured Burgess Nicholls joined the meeting

Councillor Pegg reported on the Cornwall Community Flood Forum meeting held on 4 April. Unfortunately there is still no confirmed date for Flood Warden training or delivery of the promised protective clothing although it is hoped that delivery of training will begin in six weeks time.

Councillor Pegg has a further meeting with the Environment Agency next week and filming of the documentary will take place soon.

It was proposed by Honoured Burgess Jones and seconded by Councillor Abbiss that a letter is sent to Cornwall Community Flood Forum with a copy to Cornwall Council expressing the Town Council's disappointment that whilst it has been working hard to try to improve 'community resilience' it has been forced to stand down the Flood Wardens and the Flood Plan due to lack of support from Cornwall Council. Furthermore the Council is disappointed with the response received from Cornwall Community Flood Forum regarding the requests for training and equipment. Lostwithiel is regrettably the town most prone to flooding in the county and this should entitle the town to a large percentage of funding. This proposal received the support of the Committee.

The clerk was instructed to notify Cornwall Council Fire Brigade that the Flood Wardens have been stood down.
