### 382/13 CLIMATE VISION – LUCI ISAACSON

The Council received a presentation from Luci Isaacson regarding the re-introduction of the Leaf Litter project to Castle Hill with effect from November 2013.

### 383/13 PUBLIC PARTICIPATION

The Council was addressed regarding Office 1 in Edgcumbe House, the Skate park project and the town map on the North Street car park exit.

# 384/13 APOLOGIES

Apologies for absence were received and accepted from the following Councillors:-Councillor Gillett, Councillor Hughes, Councillor Jewels, Honoured Burgess Jones, Councillor Milne and Councillor Mrs Wilkinson.

### 385/13 DECLARATIONS OF INTEREST

Councillor May declared a registerable interest in agenda items 13 & 14 Lostwithiel Rotary & a non registerable interest in agenda item 24 Accounts & Finance.

Honoured Burgess Peareth declared a non registerable interest in agenda item 24 Accounts & Finance and agenda item 34 DAS.

### 386/13 POLICE REPORT

PCSO Phillips's written report advised that there were 6 reported crimes, 2 other vehicle crimes, 3 other thefts and 1 criminal damage. There were a total of 30 logs for September.

### 387/13 CORNWALL COUNCILLOR REPORT

Cornwall Councillor Bay addressed the Council regarding the letter from Cornwall Council's Nigel Doyle Assistant Head of Planning, Housing and Regeneration which is suggesting that Lostwithiel & Lanlivery's Planning Services are administered by Planning East and not Planning Central.

Cornwall Councillor Bay also advised the Council that at a recent South West Flood Forum Finance meeting Lostwithiel was described as the most pro active Council in the South West Region. Cornwall Councillor Bay will be attending the Cornwall Community Flood Forum AGM on Thursday 10 October 2013.

Cornwall Councillor Bay also asked the Council to consider local causes which may benefit from Cornwall Councillor Bay's Community Chest fund. The minimum amount which can be applied for is £100 and the maximum £1000. The application period closes March annually.

# 395/13 ROTARY CLUB OF LOSTWITHIEL YOUTH AWARD

It was then proposed by Honoured Burgess Jones and seconded by Councillor May that the meeting is reconvened. This proposal received the support of the Council.

It was proposed by Deputy Mayor Mrs Jarrett and seconded by Councillor Robson that the clerk is instructed to advise Cornwall Council that Lostwithiel Town Council greatly values some aspects of Community Networks areas however the Council does not consider that the role of Community networks would be enhanced by Cornwall Councillors taking on the Community Network Manager roles. This proposal received the support of the Council.
