135/25 Declarations of interest

137/25 Meeting Minutes 05 August 2025

The meeting minutes dated 16 July 25 had to be amended under Minute reference **124/25** as they incorrectly recorded 8 votes instead of 7 votes. A further amendment was required under minute reference **127/25** to replace 'sings' with 'signs'. After the minutes had been amended in ink and initialled by Mayor Berryman it was **resolved** that the amended minutes of the Council Meeting held on 05 August 2025 are accepted, approved and duly signed by Mayor Berryman.

The Mayor advised that the two Open Days held in the Guildhall & Edgcumbe House respectively were well received by the public. Mayor Berryman asked that the minutes record grateful thanks to the Neighbourhood Plan Steering Group for their attendance and valued support on both days.

Mayor Berryman had 5 people attend the August Mayor's surgery, topics raised included the Wednesday Biffa collections, increasing library

opening hours, and car parking.

Mayor Berryman also advised that he had recently represented Lostwithiel Town Council at the funeral of Mr Ralph Broad a former Town Clerk.

141/25 Councillor Reports

DM Rawlings reported to Council on the recent meeting with a representative of the Environment Agency regarding their plans to do some investigative inspection work on the Flood defence walls. This will involve removal of some stones to assess the internal condition and structure of the wall. DM Rawlings and Cllr Henderson asked the EA at the meeting that the vegetation growth on the river side of the Parade wall and the vegetation growing in the silt at the bridge is brought to the attention of the EA's asset management team.

Cllr Guiterman reported that LEAF had recently taken photographs showing over 100 people bathing in the water next to the bridge. Cllr Guiterman also advised that he attended the site meeting arranged with Lanlivery Parish Council at Pelyn Tor woods. From the conversation at the site meeting Cllr Guiterman was under the impression that the views of Lanlivery Parish Council are similar to the response already submitted by Lostwithiel Town Council.

The Council discussed LEAF's application at length in light of the response from Council insurers that following a detailed review they would be unable to add this activity to the Council's insurance policy.

It was **resolved** to instruct the clerk to reply to LEAF advising that Lostwithiel Town Council supports in principle regular testing of the water for bathing quality but cannot accept as landowner any additional responsibilities that designation of the area as a designated bathing water area would require.
