183/25 Meeting Minutes 14 October 2025

186/25 Lostwithiel Town Council Flood Plan

It was **resolved** to approve the revised Flood Plan with some minor text amendments. Deputy Mayor Rawlings advised that new Flood Warden volunteers are needed for the Flood Plan to work effectively over an extended incident timeframe. Deputy Mayor Rawlings further updated Council on how the Flood Plan will work in practice with the current reduced number of Flood Wardens.

188/25 Buildings Maintenance

It was **resolved** to approve the following

Twice yearly maintenance of the Intruder alarms in Edgcumbe House and the Library £380.

Twice yearly maintenance of the Fire Alarm in Edgcumbe House & the Guildhall £410.

Annual maintenance of the CCTV system in Edgcumbe House £60.00 (to include disconnection of one camera at no charge)

Annual Maintenance of the Emergency Lighting in the Library, Edgcumbe House, Guildhall ££250.

Edgcumbe House – to supply and install a ‘CSL connect’ within the existing intruder alarm panel £120 plus VAT, to wire a link from the intruder to fire alarm to make both monitored £90 plus VAT & to apply and pay for Police connection fee £80 plus VAT.

Guildhall – to install a CP20 control panel and a CSL Connect above the existing fire alarm panel and link the two to allow the fire alarm to signal via the wi-fi £262 plus VAT.
