

Lostwithiel Town Council Meeting Tuesday 02 December 2025

Cornwall Councillor Report

Cornwall Councillor Preece sent apologies and provided a written report which was read to Council by Mayor Berryman. The report provided updates on the Community Highways Improvement Programme, Community CIL funding and recent Government announcements regarding:-

- Exploring designating Cornwall Council as a Single Foundation Strategic Authority putting us on an equal footing with the mayoral authorities
- The continuation of the 100% Business Rates Retention Scheme for the Council
- £30m of Kernow Industrial Growth Funding, giving us some continuity for economic growth and making Cornwall Council the only non-mayoral authority to hold either a locally-led 'Growth Fund' or Business Rates Retention System (BRRS) Scheme
- Lodging a request with the Council of Europe to increase the UK's formal recognition of Cornwall's Celtic language, Kernewek, from Part II to Part III, creating parity with all the other Celtic languages
- Confirmation from the Minister for Housing and Planning that Homes England are willing to further develop their partnership working with Cornwall with a focus on delivering affordable housing.

Pre application Planning Presentation - Mr Sleep Mayor Berryman read the following paragraph to the meeting:-Whilst Members may express an opinion for or against the proposed development plans at this meeting Members minds are not closed and they will only come to a conclusion on whether they should support the scheme or offer an objection after they have listened to the full debate.'

Mr Sleep advised Council of his intentions to apply for planning permission on land in his ownership and the environmental benefits he intended to provide onsite in addition to the proposed new leisure based business.

In Section 14 under the Target response time the report reads 'Works completed within 14 days (Or barrier off until resources available). In Section 17 could point 1 and point 2 be deleted and the second paragraph be amended to read

'Private trees remain the owner's responsibility. Where a privately owned tree in falling distance of the public highway or public open space is considered to pose a danger, the Council will record the issue and notify Cornwall Council.'

Appendix 1 site map – would it be possible to delete the small rectangular area outlined at the Cemetery & Allotments as this is not in the Town Council's ownership.

In some of the risk assessments and the general text the suggestion put forward is that the Council should 'monitor use of the beach area' – could you please expand on how you would recommend the Council does this. Recommendations page

Would it be possible to amend the first bullet point to read Consider asking Fowey Harbour Commission to introduce water quality testing at the beach area

Fourth bullet point

Could the text be amended to read - Liaise with South West Water to establish who is responsible for inspecting and maintaining the ladders on Pill Walk

Bullet point 10

The Council doesn't wish to liaise with Defra regarding this sign, at last night's meeting Council Members felt that this had the potential to adversely impact the DBA application. Council would prefer, if possible, to remove this sign and replace it with one of the text only signs with the same

wording as ///truckload.sloping.denser

With reference to public fishing rights the Council considers that the sign photographed was taken out of context and referred simply to the conflict in that specific location with overhead power lines.

Would it be possible to please advise the costs of water safety literature, resources and support for community education programmes from RLSS UK. The Council is thinking specifically about visits to the two primary schools located in the town.

Would it be possible to please reissue the document with Fowey and Quay Street spelt correctly, the Council intends to share the document with Fowey Harbour Commission and South West Water as a minimum and doesn't wish to cause any offence to the Harbour Master.
