



## **Lostwithiel Town Council Meeting Tuesday 03 February 2026**

### **Cornwall Councillor Report**

Cornwall Councillor Sarah Preece reported on the impact and response following Storm Goretta and that over 1000 trees have been lost across Cornwall, but the final figure is likely to be much higher. On a more local level in Lostwithiel the distinction between Cornwall Council owned land and private land has been challenging. Cornwall Council as a multi-agency partner definitely has an appetite to learn from what has happened and is consulting on ways to best support communities.

As Portfolio holder for Tourism, Cornwall Councillor Sarah Preece hosted a Tourism Summit at Eden and has been leading the conversation to advocate for Cornwall and to ensure our visitor economy has the representation it needs following the demise of Visit Cornwall.

Cornwall Councillor Preece also reported on a number of funding opportunities and current consultations.
