Lostwithiel Town Council – Planning Committee Meeting

Tuesday 11 November 2014

A Meeting of the Town Council's Planning Committee was held in the Guildhall on Tuesday 11 November 2014.

527/14 AFFORDABLE HOUSING

Cornwall Council Officer Andrew O'Brien explained to the Council how the Affordable Housing element of the planning applications recently approved in the Lostwithiel area will be administered by Cornwall Council. Mr O'Brien also encouraged members to refer to the Affordable Housing bite size guides recently issued by Cornwall Council and recommended to Council members that anyone interested in an affordable home to register with the Home choice Team at Cornwall Housing Ltd and/or the Help to Buy South West agency. Priority will be given to people on these registers from Lostwithiel; if Lostwithiel cannot fill all the vacancies then it will be opened up to the wider Cornish community. Mr O'Brien reassured the Town Council that it would be kept informed in order that the local Council can promote the availability of the properties at the right time. The Town Council cannot be involved in the allocation process. The Affordable Housing Team aim to work proactively with Town & Parish Council's and can assist with a web based local needs survey. The results of which can then be incorporated into a Neighbourhood Plan i.e. two/three bedroom houses v smaller bungalows for the elderly.

The Committee was addressed regarding a proposal for 6/7 properties 200 yards outside the development boundary.

- a) Flood Plan Councillor Mrs Ross advised the Committee that the test event last Wednesday was successful and illustrated the need for more radio batteries. The next test will be conducted in daylight and the Flood Wardens would like to distribute a letter advising that the Town Council does not supply sandbags. The Committee also needs to agree which properties will be invited to participate in the Flood sax project. Councillor Mrs Ross offered to write the letter regarding sandbags and to make a list of 'Flood sax properties'. This offer was accepted by the Committee. The possible need for more Flood Wardens was discussed an it was considered that the Council should ask for more volunteers if sufficient candidates come forward then it should be possible to hold further training events in Lostwithiel.
- b) Neighbourhood Development Plan Councillor Hughes advised the Committee that the next meeting will be held in Golant on 20 November and that Councillor Jewels will represent Lostwithiel Town Council.
- c) Cornwall Council Community Emergency Plan template It was proposed by Councillor Mrs Ross and seconded by Councillor Watkins that the Committee accepts Councillor Hughes's offer to contact Mr Tony Garvin to assess the expectations and gain clarification on the Community Emergency Plan requirements.
