a) Flood Plan – to receive an update

Councillor Gillett presented a verbal report to Council on the meeting with Cormac. Councillor Gillett is hopeful that Cormac when they have had the opportunity to review the current terms will make the necessary arrangements to make any future agreement less regimented. In the interim Cornwall Council as last year have the responsibility for maintenance of the grass verges.

862/14 COULSON PARK – NEW SEAT BENCH

It was proposed by Councillor Watkins and seconded by Councillor Mrs Ross that the price of £250 to supply a new 8 foot bench for Coulson Park is accepted by Council. This proposal received the support of the Council.

863/14 EDGCUMBE HOUSE

a) to receive the minutes of the meetings held on 26 February & 26 March

Councillor Mrs Ross asked the Council to defer this agenda item to the next meeting.

b) an update from the working party

No update was available.

The clerk read to Council an email from Cornwall Association of Local Councils dated 25 March regarding Edgcumbe House:-

The Council owns the building and therefore has a legal obligation to ensure that it does not become dangerous. Whilst I understand the resolution agreed as part of the precept discussions, the council must also understand that this is an asset of the council with a value which is diminishing due to its condition. It must be able to justify not only why it decided to mothball the building but also why it also allowed its value to continue to fall and its condition to deteriorate.

You will also need to check with the insurance company as to any structural requirements imposed by them in order to maintain cover.

c) to report on the Edgcumbe House open day

It was agreed by Council members that the open morning will be held on Saturday 9 May

864/14 ANNUAL PARISH MEETING

It was decided that the meeting should be held on a Monday night either in the Church Rooms or the Community Centre. The format of the meeting should be as previous years and Cornwall Council's Tasha Davis should be invited to address the meeting.

865/14 LOSTWITHIEL IMPROVEMENT PROJECTS

Mayor Mrs Jarrett advised Council that she has received an offer of new gates for King George V playing field at no cost to the Council. The existing hinges would be cleaned, have a new zinc coating and be plastic capped. There would be a latching bolt and a stainless steel bolt into the ground with a metal insert. KG5 will be on a polished stainless steel disc at the centre of the two gates and there would be a link and padlock on the rear of the centre design.

The Mayor also wishes to replace the 'Lostwithiel signs' using a suggestion from the business group that the signs have a banner top as per the information boards.

The Mayor also wishes to replace the Welcome to Lostwithiel box with a new box with wording on the side the same but on a plain background.

It was proposed by Deputy Mayor May and seconded by Councillor Watkins that all the above listed projects are supported by Lostwithiel Town Council with the proviso that the King George V playing field is kept secure and not left without gates. This proposal received the support of the Council.

Honoured Burgess Jones asked it to be recorded in the minutes that he abstained.

866/14 INSURANCE

The clerk circulated to Council copies of last year's insurance minutes, Zurich's original and revised 2015 schedules, levels of cover and annual quotation. It was proposed by Councillor Mrs Ross and seconded by Councillor Robson that the insurance is renewed as per the revised quotation at a cost of £4775.33 with a reduction in street furniture and play areas cover. (Skatepark & Coulson Park now having separate listings). This proposal received the support of the Council.
