# 273/15 CORNWALL COUNCILLOR REPORT

Cornwall Councillor Bay advised the meeting that she could find no valid planning reason to support the Town Council's request to forward planning application PA15/05375 Lostwithiel Golf & Country Club Construction and the provision of 4 affordable homes for sale or rent to local people to Cornwall Council's Planning Committee for consideration. All the issues raised by the Town Council relating to this application have been resolved.

Cornwall Councillor Bay offered to arrange for Cornwall Council Planning Officers to attend a Lostwithiel Town Council meeting. This offer was gratefully accepted by Council.

#### 275/15 LOSTWITHIEL TOWN COUNCIL COMMUNITY RESILIENCE

a) Flood Plan

Councillor Mrs Ross advised Council that two Flood Warden training sessions have been held recently and all new wardens attended both sessions so there are now a number of new fully trained Flood Wardens. There will be a test event on Tuesday 13 October; all Wardens will be pre-notified of the test event to ensure maximum attendance. New PPE equipment has been purchased and Councillor Mrs Ross is still endeavouring to move the pilot project forward.

- b) Neighbourhood Plan
  - (i) Approval of Neighbourhood Plan working party minutes.

It was proposed by Councillor Robson and seconded by Councillor Mrs Parsons that the Lostwithiel Town Council Neighbourhood Plan working party minutes dated 21 September 2015 are approved as drafted. This proposal received the support of the members of the working party present.

(ii) Proposed purchase of a gazebo, notice board & exhibition stand from the Council's Neighbourhood Plan earmarked reserves.

It was proposed by Mayor Mrs Jarrett and seconded by Councillor Mrs Ross that the Council does not consider purchasing an exhibition stand at this time but that prices are obtained for a gazebo and notice board for consideration by Council at the November Council meeting. This proposal received the support of the Council.

Approval of the wording of the press release, covering letter and newspaper notice. (iii) It was proposed by Councillor Robson and seconded by Deputy Mayor May that the wording is approved subject to the suggested amendments of the town clerk. This proposal received the support of the Council.

## 282/15 EDGCUMBE HOUSE & GUILDHALL

Portfolio Holder Councillor Watkins reported on the meeting held with the contractor and Scott & Co on 21 September 2015. The buildings will be closed to public, Councillor and staff access from this date for the duration of the works and any works instructions to or from the contractors will be via Scott & Co and the Town Council office.

Councillor Hughes reported on a very successful meeting with Cornwall Council officer Nigel Blackler and John Scott of Lostwithiel Town Forum. Mr Blackler has offered Cornwall Council support to Lostwithiel's objectives.

It was proposed by Councillor Robson and seconded by Councillor Brewer that Lostwithiel Town Council accepts Councillor Hughes's suggestion that the Town Council and the Town Forum work together to achieve results with the Town Council taking the lead on all correspondence between Lostwithiel and Cornwall Council. This proposal received the support of the Council.

Councillor Hughes offered to circulate a drafted response to Mr Blacker to Town Councillors, members of the Town Forum and the town clerk prior to forwarding to Mr Blackler. This offer was gratefully accepted by Council.
