## 330/15 PRESENTATION BY MEMBERS OF THE EDGCUMBE HOUSE WORKING PARTY

Mr M Pearson from the Edgcumbe House working party briefly outlined the project. Dr C Yates explained funding opportunities that may be available and Dr J Scott governance options.

## 334/15 COMMUNITY POLICE REPORT

Mayor Mrs Jarrett read the October report to Council. For the period 01/10/15 - 25/10/15 there was one violence without injury crime, one dwelling burglary, one shoplifting crime and one trafficking of drugs crime.

## 335/15 CORNWALL COUNCILLOR REPORT

The clerk read to Council Cornwall Councillor Jenkinson's report.

Cornwall Councillor Jenkinson requested that the Grant funding that is available to rural businesses, farmers, foresters and communities is brought to the attention of the Council. The project is under the LEADER umbrella (South & East Cornwall Action Group). Leader is part of the Rural Development Programme for England. Funded by the European Agricultural Fund for Rural Development. There is a pot of £7.3 million available through the Leader delivery framework across Cornwall. Leader will fund farmers, foresters, rural businesses and communities to help:

Create jobs

Develop rural businesses

Support the rural economy

70% of activity has to deliver growth and jobs with 30% delivering indirect growth.

Most grants will be limited to 50% of the projects total eligible costs. The minimum application amount is £2,500 and the maximum grant amount is £35,000.

The 6 priorities for Leader are to

Increase farm productivity

Support micro and small businesses and farm diversification

Boost rural tourism

Provide rural services

Provide cultural and heritage activities

Increase forestry productivity

Councillor Jewels having previously declared a non-registerable interest in this planning application left the meeting room.

It was proposed by Councillor Robson and seconded by Councillor Mrs Wilkinson that Lostwithiel Town Council supports this application. The Town Council considers the proposal will enhance the immediate locality and will provide housing for a couple local to the Lostwithiel area. This proposal received the support of the Council.

Councillor Jewels rejoined the meeting.

PA15/09584 Trenant Victoria Lostwithiel

Works to trees in a Conservation Area namely T1 – Reduce Beech hedgerow by 3-4metres, T2 Fell apple tree and T3 Crown reduce Italian alder by 2 metres.

Lostwithiel Town Council did not consider this application having been advised by Cornwall Council that it will be determined under delegated authority.

PA15/09734 Stannary House 6 Quay Street Lostwithiel

Renovation of the existing utility room into kitchen/dining area.

This proposal received the support of the Council.
- (iii) It was proposed by Councillor Watkins and seconded by Councillor Abbiss that the working party should forward the completed consultant shortlist the Council as soon as available. This proposal received the support of the Council.

## 344/15 LOSTWITHIEL BUSINESS GROUP – DICKENSIAN EVENING

It was proposed by Councillor Watkins and seconded by Councillor Robson that permission is granted for the use of the corner of the Parade next to the Drill Hall for Dickensian Night on 10th December 2015 for a stage for Lost In Song and other musicians and singers subject to the Council's receipt of the necessary 'Use of Town Council Land' information. This proposal received the support of the Council. Councillor Robson added that the Council might wish to highlight that currently it is unable to confirm if the public toilet facility will be re-opened for the event.

## 348/15 THE PARADE BRAMBLES NETTLES & SYCAMORE SEEDLINGS

It was proposed by Councillor Jewels and seconded by Councillor Robson that initially the Council accepts Deputy Mayor May's offer to look at the brambles, nettles and sycamore seedlings on the river wall. This proposal received the support of the Council.

# 349/15 ACCOUNTS & FINANCE

Deputy Mayor May & Councillor Watkins having previously declared pecuniary interests left the meeting room.

Mayor Mrs Jarrett explained to Council that cheque number 100372 is in excess of the amount agreed by Council. Mayor Mrs Jarrett accounted for why the figure was higher and advised that she had contacted a number of Councillors prior to agreeing the increased fee with the contractor. Furthermore storage fees will

not now be payable and will partially offset the cost. It was proposed by Councillor Guiterman and seconded by Councillor Jewels that the actions of Mayor Mrs Jarrett are endorsed retrospectively. It was proposed by Councillor Robson and seconded by Councillor Gillett that cheques numbers 100372 – 100387 totalling £5542.13 are authorised for payment.
