454/15 EDGCUMBE HOUSE UPDATE

Councillor Watkins advised Council that the Mayor, Deputy Mayor, Councillor Watkins and the clerk met with Scott and Co and representatives from the contractors on Thursday 28 January for a project update. Councillor Watkins updated Council on progress.

Downstairs Council office – It was proposed by Councillor Watkins and seconded by Councillor Gillett that works are not undertaken in this office to restore the fixtures in the room back to the original i.e. remove the shelf stacking system and to improve the recesses at a approximate cost of £1,000 prior to the room being redecorated. This proposal received the support of the Council.

First Floor Office (office above downstairs Town clerk's office)

It was proposed by Councillor Watkins and seconded by Councillor Jewels that Scott & Co are instructed to apply for listed building consent to remove the cupboards and dresser top but no instruction is to be given for the actual removal of these items if the application is successful. This proposal received the support of the Council.

Carpets – It was proposed by Councillor Watkins and seconded by Councillor Jewels that subject to the criteria expressed in Council minute 422/15 Scott & Co are authorised to choose the replacement carpets. This proposal received the support of the Council.

The Council was advised that repairs to the ladies toilet ceiling are going to be undertaken free of charge, the drain outside the rear door to Edgcumbe House will be cleared free of charge and that Scott & Co will be asked to change the date of next month's site meeting due to the unavailability of the clerk.

The clerk advised that she had asked at the site meeting with Scott & Co and the contractors and had been advised that in May 2016 Edgcumbe House will still be a construction site so public access will not be possible.

It was further proposed that the clerk should advise that Mayor Mrs Jarrett & Councillor Watkins will meet with members of the Museum Committee to further explain the position if required. This proposal received the support of the Council.
