Environment narrative – sentence beginning 'Second Island is to be planted.... across the meadow' to be deleted. Next paragraph second line insert the word Council. Third paragraph from the end to be amended to read'land side of the Moor. There is a potential for obtaining protection as a Local Nature Reserve once issues of public access have been established.

It was decided that as a matter of courtesy the Council should approach the Duchy of Cornwall prior to the question Retain and enhance Second Island Park as a natural open space with public access.
